Good morning all,

I have referred the attached memorandum to Commissioner Wilkinson who responds:

The court finds the proposed approach for mediation sensible and directs:

A. *Further to Appendix 2, the court is unavailable in the week of 4 March 2024 and therefore I propose the below schedule:*

- *The Objectives, polices and rules topic is to be set down on 12-14 March and 19- 21 March 2024*
- *The Allocation method topic is to be set down on 26-28 March 2024*
- *The remaining topics are to be scheduled as set out in Appendix 2.*

B. *The Council is to circulate a preliminary position paper at least **10 working days** prior to the date of mediation;*

C. *Appellants and Section 274 parties are then to circulate their response within **5 working days**;*

- D. *The Aquaculture Interests are to provide the court with an update on the deferred appeal points by **29 February 2024**; and*
- E. *The Council is to file a reporting memorandum for the balance of appeals requiring mediation by **28 June 2024**.*

Parties are advised that Notices of Mediation will issue in due course.
